Promotion Regulations "Activejet newsletter - 10% discount".

§ 1 Definitions

- 1. **Promotion** the promotion "**Activejet Newsletter 10% discount**" for Participants purchasing Products from the Organizer, organized and conducted on the principles described in these Regulations.
- 2. These Regulations ("Regulations") set out the rules for the use of the Promotion, the conditions and scope of the complaint procedure, the rights of the Participant, the obligations of the Organizer.
- 3. Organizer The Organizer of the Promotion is ACTION Spółka Akcyjna with its registered office in Zamienie at 10 Dawidowska Street, post code 05-500 Piaseczno, entered in the Register of Entrepreneurs kept by the District Court for the Capital City of Warsaw in Warsaw, XIV Business Department under KRS number 0000214038, NIP 5271107221, REGON 011909816, BDO 000035215, with a share capital of PLN 1,653,700 ("Organizer").
- 4. **Product(s)** any product(s) available in the Online Store.
- Newsletter database a database of e-mail addresses to which periodic notifications about news, promotions and the Organizer's offer are sent by the Organizer.
- 6. **Newsletter** a service provided electronically by the Organizer consisting of sending information containing commercial content, including: information about products, news, promotional and contest actions of the Online Store.
- 7. **Discount code** a unique code that allows you to make a one-time purchase of any product or products with a discount of 10% for purchases with a minimum cart value of PLN 50 gross. The discount is calculated on the total value of the order. Activejet desks and armchairs are excluded from the promotion.
- 8. **Participant** an adult natural person, having a place of residence on the territory of the Republic of Poland, purchasing the Product as a consumer within the meaning of Article 22(1) of the Civil Code and entities with legal personality.
- 9. Online shop- Online store

§ 2 General provisions

- 1. The promotion is conducted on the territory of the Republic of Poland in the period: from 10.09.2024. until further notice.
- 2. The promotion does not combine with other promotions conducted by the Organizer.

§ 3 Promotion Rules

- 1. In order to participate in the Promotion, the Participant should subscribe to the newsletter database using the pop-up form on the Organizer's website www.activejet.pl.
- 2. The Organizer will send the -10% discount coupon to the email address provided by the Participant, provided that the email address is not already listed in the Newsletter Database. The Participant in the field to provide an e-mail address should provide his/her e-mail address, which is correct and up-to-date. It is not allowed to provide e-mail addresses of third parties.
- 3. The Participant may withdraw consent to receive the Newsletter at any time, and the withdrawal of such consent shall not affect the legality of data processing prior to its withdrawal
- 4. Each Newsletter sent to the Participant includes options for opting out of the Newsletter service. The Participant has the right to unsubscribe from the Newsletter service by unchecking the consents to receive commercial, marketing information located in his/her customer account or by clicking on the link located in the email received from the Online Store, which will redirect the Participant to his/her account to uncheck the aforementioned consents.

- 5. A participant who meets the conditions listed in items. 1, 2, above, is entitled to use the Discount Code received from the Organizer once. The Discount Code should be entered in the appropriate field in the shopping cart at the first stage of order processing. The Discount Code should be redeemed in the sferis.pl online store
- 6. The price of the Product(s) in the Online Store will be determined each time by the Organizer and may change during the Promotion. The price of the Product(s) listed in the Online Store does not include the value of the discount indicated in § 1.7 above.
- 7. The Promotion Organizer in connection with the sale of the Product will issue a sales document confirming the transaction. The sales document shall constitute proof of purchase, pursuant to the provisions of §4 of the Regulations.
- 8. The Organizer does not provide for the possibility of exchanging the Products in the Promotion or the Discount Code for their cash equivalent or for other Products included and/or not included in the Promotion.
- 9. Products purchased by the Participant using the Discount Code are subject to the general terms and conditions for returns in connection with withdrawal from a distance contract. If the Customer returns a Product purchased under the Promotion, the Organizer will refund the Customer only the price actually paid for the Product (the price reduced by the value of the Discount).

§ 4 Complaints

- All complaints of Participants related to the Promotion may be submitted within 30 days from the date of purchase of the Product(s).
 The complaint should be sent by mail to the following address of the Organizer: Zamienie, 10 Dawidowska St., 05-500 Piaseczno or by e-mail to: sklep@sferis.pl.
- 2. The complaint should contain, under pain of invalidity, the Participant's name, mailing address and a detailed description of the circumstances giving rise to the complaint, including in particular a copy of the document confirming the purchase of the Product (e.g.: invoice).
- 3. Complaints submitted will be processed within 14 days from the date of receipt of the complaint.

§ 5 Personal data

- 1. The personal data of the Promotion Participants shall be processed on the basis of the provisions of generally applicable law on the protection of personal data and the Regulation of the European Parliament and of the Council of the EU of April 27, 2016 on the protection of natural persons in relation to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (hereinafter referred to as RODO).
- 2. The Organizer is the administrator of the personal data. Our contact details are: e-mail address: iod@action.pl postal address: Data Protection Inspector Action S.A., Zamienie, 10 Dawidowska St., 05-50 Piaseczno.
- 3. Providing personal data is not a statutory or contractual requirement, but failure to do so prevents participation in the Promotion. Acceptance of the Terms and Conditions is the basis for processing of the Promotion Participant's personal data for purposes related to the Promotion (legal basis for processing Article 6(1)(b) RODO).
- 4. We will process your data for the following purposes:
- organization and execution of the Promotion, answering your questions related to the Promotion and handling your complaints, executing the sales contract concluded with us. Legal basis: art. 6(1)(f).
- if you have given your consent to receive commercial and marketing information, it can be revoked at any time and your personal data
 necessary for sending them will be processed on the basis of the Administrator's legitimate interest. Legal basis: art. 6(1)(f).
- Your data may also be processed to assert or defend against claims related to the Promotion. The legal basis for the processing is its necessity for the realization of the administrator's legitimate interest; the administrator's legitimate interest is to be able to assert or defend its rights in connection with the Promotion. Legal basis: art. 6(1)(f).
- 5. We will process your personal data for the duration of the Promotion, with the following exceptions:
 - for the purpose of asserting claims or defending against claims also after the expiration of the aforementioned period, but no longer than the period of the statute of limitations for claims under the law.

- 6. Participants' data may be transferred to entities: those cooperating with us, responsible for the proper conduct of the Promotion; those providing transportation and courier services.
- 7. The participant has the right to access, rectify, erase or restrict the processing of his/her personal data, as well as the right to data portability, if there are legal or factual grounds to do so.
- 8. The participant also has the right to file a complaint regarding our processing of personal data to the supervisory authority, which is the President of the Office for Personal Data Protection, 2 Stawki Street, 00-193 Warsaw.
- 9. To the extent that the basis for the processing of personal data is the legitimate interest of the controller, the Participant has the right to object to the processing of his/her personal data, for reasons related to his/her particular situation.
- 10. The Organizer declares that the data of the Promotion participants will not be processed in an automated manner and will not be subject to profiling.

§ 6 Final provisions

- 1. By participating in the Promotion, the Participant confirms that he/she agrees to participate in the Promotion under the terms of the Terms and Conditions.
- 2. The content of these Terms and Conditions will be available at the Organizer's office and in the Online Store. Basic information about the Promotion and its rules will be included in promotional materials distributed by the Organizer in connection with the Promotion.
- 3. In the case of correspondence, the deadline is determined by the date of posting, unless otherwise stipulated in the body of these Regulations.
- 4. In matters not covered by these regulations, the generally applicable provisions of law shall apply.
- 5. Any disputes that may arise in connection with the implementation of this Promotion will be resolved amicably.
